• § 1 Scope and the basis of the services provided

- 1. DB Cargo Polska S.A. (hereinafter referred to as "DBC PL") provides freight services of goods.
- 2. DB Cargo Polska S.A. provides additional services that accompany transport services.
- 3. The scope and conditions of transport services and additional services provided are specified in: Freight Shipment Transport Instruction of DB Cargo Polska S.A. [PL: Regulamin Przewozu Przesyłek Towarowych DB Cargo Polska S.A.], hereby Tariff, Transport Contracts concluded with DB Cargo Polska S.A., and national and international transport regulations applicable to rail transport.

• § 2 Scope of DB Cargo Polska S.A. Tariff application

- 1. The DB Cargo Polska S.A. Tariff, hereinafter also referred to as the "Tariff", determines:
 - rules for determining fees for the performance of the transport of shipments (Freight);
 - rules for determining the rates of additional fees for additional services provided by the Carrier;
 - rates for transport on available standard-gauge lines on the territory of Poland;
 - the amount of additional fees;
 - rules for regulating payments for the service provided.

The rates of additional fees included in hereby Tariff also apply to services on the 1520 mm track on the territory of Poland.

- 2. The Tariff does not apply to the transport of extraordinary, sensitive and dangerous shipments.
- 3. Fees for the performance of shipments transport services and additional services are calculated separately for each of the services provided.
- 4. At the Customer's request, DBC PL may present an individual transport offer, taking into account the Customer's specific requirements regarding the technical, organizational and economic conditions of the service provided.
- 5. The provisions of the DBC PL Freight Shipment Transport Instruction and hereby Tariff apply to transport performed on the basis of transport contracts concluded with DBC PL, or transport orders issued by the Customer based on the accepted DBC PL transport offers or hereby Tariff, as well as to additional services performed on the basis of contracts concluded with DBC PL, unless the content of these contracts or accepted transport offers submitted by DBC PL does not contain different regulations.
- 6. The definitions contained in the Freight Shipment Transport Instruction of DB Cargo Polska S.A. apply to the hereby Tariff.

• § 3 Tariff distance

The transport distance used for the rates calculation (tariff distance) is determined on the basis of the planned route of the train according to the PKP PLK "Kalkulacja" program, which is available at: <u>https://skrj.plk-sa.pl/kalkulacja/</u>.

• § 4 Weight of the shipment

The weight of the shipment, hereinafter referred to as the "contractual weight", is the weight resulting from the transport contract or transport order, determined on the basis of the technical parameters of the wagons required for transport and the parameters of the transported goods. In order to calculate the freightage, the actual weight of the shipment, resulting from the weight measurement at the Sender's, shall be used. This weight is entered in the consignment note with an accuracy of 1 kilogram.

§ 5 Principles for determining rates for the transport of bulk, intermodal and automotive, as well as additional fees

- 1. The following forms of the Freight calculation are distinguished, depending on the type of ordered shipments:
 - in the case of transporting bulk goods, including coal, construction aggregates, iron ores etc., weighing not less than 1000 tons, the freight charge will be calculated at the rate for 1 ton of the transported weight of the shipment. A detailed list of rates is included in Table 1A;
 - in the case of transporting bulk goods, including those listed above, weighing less than 1000 tons, a rate calculated each time individually is applied;
 - in the case of wagon shipments, the rate per wagon is applied, each time individually calculated;
 - in other cases, such as: international shipments, transport of rolling stock rolling on its own wheels, dangerous goods, the rate is determined each time on the basis of individual calculations;
 - for automotive transport (transport of cars and empty wagons used for such transport) and intermodal (transport of intermodal transport units and empty wagons used for such transport) in block train shipments in wagons delivered by the Customer, the Freight is calculated according to the rates for the train from Table No. 1B;
 - for automotive transport (transport of cars and empty wagons used for such transport) and intermodal (transport of intermodal transport units and empty wagons used for such transport) in block train shipments in wagons delivered by the DBC PL, a rate is applied, each time individually calculated.
- 2. Special conditions for calculating the Freight for the bulk transports:
 - in the case when DBC PL has substituted wagons for loading in accordance with the order and technically efficient, and the actual weight of the shipment is lower than the contractual weight of the shipment, but remains in the same tonnage range of Table No. 1, the rates are calculated according to the rate from the range appropriate for the contractual weight shipments;
 - in the case when the actual weight of the shipment is higher than the contractual weight of the shipment, the Freight is calculated according to the rate from the range appropriate for the contracted weight of the shipment;
 - in the case when the actual weight of the shipment is lower than the contracted weight and moves to a lower tonnage range given in Table No. 1, the Freight of the entire shipment is calculated at the rate appropriate for the actual weight;
 - in the event of resignation from the ordered transport service or change of the date of the ordered transport service, for reasons not attributable to DBC PL:

shall <mark>prevail</mark>.

- a) within more than 72 hours from the planned start of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 15% of the agreed freight rate;
- b) between 72 hours and 48 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 30% of the agreed freight rate;
- c) between 48 hours and 24 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 50% of the agreed freight rate;
- d) less than 24 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 100% of the agreed freight rate;
- e) free cancellation of transport until Thursday of the preceding week.

An invoice for the above-mentioned fee will be issued in accordance with the applicable regulations. The Customer's information about the cancellation or change of the transport date shall be sent in writing or to the following e-mail addresses:

- 3. Rates for transport of bulk goods (see: Table No. 1A), unless otherwise agreed, include:
 - transport of empty wagons for loading to the delivery-receiving point at the sending station;
 - transport of loaded wagons from the delivery-receiving point at the sending station to the delivery-receiving point at the receiving station;
 - transport of empty wagons after unloading, monitoring and notification of the shipment in the basic scope including information about the planned time of train departure, number of wagons, net weight, estimated (scheduled) arrival time as well as any obstacles in transport, including theft of goods.
- 4. Rates for transport of bulk goods (see: Table No. 1A), unless otherwise agreed, do not include, in particular:
 - shunting works;
 - siding and terminal services;
 - costs of using the infrastructure at the sending or receiving station;
 - stay of wagons for loading operations;
 - passing the railway infrastructure not managed by PKP PLK;
 - the infrastructure manager's reservation fee for the ordered and allocated train route; not used in whole or in part for reasons beyond the control of DBC PL;
 - monitoring and notification of the shipment in the extended scope, including tracking the train and providing information about its current location and estimated arrival time at the destination station, border or other station as expected by the Customer, and notification of the shipment to more than one entity involved in the transport process;
 - security costs;
 - any additional fees, in particular administrative fees and other fees of a similar nature;
 - costs of access to railway lines managed by PKP PLK SA, on which no annual timetable is prepared (lines requiring individual calculation with PKP PLK);

shall prevail.

- customs costs;
- any border and customs costs collected by Customs Authorities and Inspection Services.
- 5. Rates for the transport of 1 tonne of bulk goods on available standard-gauge railway lines in the territory of Poland, in a single block train with a minimum weight of: 1000, 1500 and 2000 t using 4-axle coal wagons of normal construction (Ea series), at the disposal of DBC PL, with a loading of 50t / wagon and the use of d-traction is specified in Table No. 1A:

6. The above rates also apply to bulk goods other than those listed in the paragraph 1, with similar physical properties and parameters, transported in Ea series wagons and enabling the use of the load capacity of these wagons.

shall prevail.

- 7. Rates for transport with parameters other than those specified above are determined individually, taking into account:
 - type of goods;
 - weight of the shipment;
 - total transport volume;
 - frequency of transport;
 - conditions of origin and destination stations;
 - specific requirements for organisation of transport;
 - specific requirements for the quality of transport;
 - type of wagons;
 - specific requirements for rolling stock;
 - other parameters agreed with the Customer.
- 8. The Freight rates for the intermodal and automotive transport in block train shipments in wagons provided by the Customer on available standard-gauge railway lines in the territory of Poland is determined in Table No. 1B:

distance determined on the basis of the planned route of the train according to the PKP PLK "Kalkulacja" program, which is available at <u>https://skrj.plk-sa.pl/kalkulacja/</u>. The Freight rate is valid for one direction. In the case of a train with a gross tonnage lower than 500t, the rate is calculated as for 500t. In the case of transport, which parameters exceed the limits of the above-mentioned table, the price must be calculated on the basis of an individual calculation.

- 10. Special conditions for rates calculation for intermodal and automotive transport:
 - in the event of cancellation of the ordered transport service or change of the date of the ordered transport service for reasons not attributable to DBC PL:
 - f) within more than 72 hours from the scheduled start of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 15% of the agreed freight rate;
 - g) between 72 hours and 48 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 30% of the agreed freight rate;
 - between 48 hours and 24 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 50% of the agreed freight rate;
 - i) less than 24 hours before the planned departure of the train, the Carrier may charge the customer a fee for cancellation or rescheduling of the transport in the amount of 100% of the agreed freight rate;
 - j) free cancellation of transport until Thursday of the preceding week.

 - transports carried out on the PKP PLK network.
- 12. Rates for intermodal and automotive transport, unless otherwise agreed, do not include:
 - shunting works;
 - siding services;
 - costs of access to terminals;
 - additional charges at terminals (storage, reloading);
 - costs of access to service infrastructure facilities;
 - wagons costs;
 - container costs;
 - infrastructure manager's reservation fee of the for the ordered and allocated train route; not used in whole or in part for reasons beyond the control of DBC PL;

shall <mark>prevail</mark>.

- costs of access to railway lines managed by PKP PLK SA, on which no annual timetable is prepared (lines requiring an individual calculation with PKP PLK);
- costs of access to the infrastructure for managers other than PKP PLK SA;
- monitoring and notification of the shipment in the extended scope, including tracking the train and providing information about its current location and estimated arrival time at the destination station, border or other station as expected by the Customer, and notification of the shipment to more than one entity involved in the transport process;
- delivery of empty wagons for loading;
- returning empty wagons after unloading;
- shipping protection costs;
- customs costs;
- any border and customs costs charged by the Customs Authorities and Inspection Services;
- loose locomotive drive in order to pick up a shipment from the sending station;
- costs related to the organisation of transport with an extraordinary shipment;
- any additional fees.
- 13. All rates and fees indicated in hereby Tariff are net amounts to which value added tax (VAT) shall be added in accordance with applicable regulations.

• § 6 Supplementary rules

 The Customer shall be responsible for any damage to the wagons resulting from his fault or the fault of his subcontractor or other entity acting at his request or on his behalf (in particular the sender, recipient or reloader). The claim against the customer covers the full amount of the repair costs incurred by DBC PL or resulting from the calculation and the total costs of decommissioning the wagons, including lost profits.

• § 7 Settlement rules

- 1. The forms of settlements and payment terms shall be included in the Transport Contracts or in accepted transport offers submitted by DBC PL, if the transport is carried out on the basis of transport orders issued on the basis of these transport offers.
- 2. In case of transport order or other additional service carried out on the basis of hereby Tariff and the Freight Shipments Transport Instruction of DB Cargo Polska S.A. the form of settlement is a prepayment calculated and made by the Customer to the account indicated by DBC PL. Only in the case of additional services, with the consent of DBC PL, a deferred payment date is possible up to 14 days from the invoice date.
- 3. For the performance of services, an invoice shall be issued each time in accordance with the applicable provisions of the Act on Value Added Tax. The invoice shall be issued after the service has been completed on the basis of data registered in the Carrier's production system or on the basis of a bilaterally signed protocol. The data to be included in the invoice are described in detail in Appendix No. 1.

§ 8 Validity period of the Freight Tariff

- 1. The hereby Freight Tariff comes into force on January 1, 2023 and is applicable for an indefinite period.
- 2. DB Cargo Polska S.A. reserves the right to make changes to hereby Tariff at any time.
- 3. Changes to the Tariff shall be introduced by publishing them on the website www.pl.dbcargo.com and they come into force from the date of their publication.
